The Branch Annual Dinner and AGM was held on Tuesday March 15th 2016, at the Quorn Lodge Hotel, Asfordby Road, Melton Mowbray, LE13 0HR, and commenced with a two course pre booked meal.

Minutes of the Last Meeting:

The minutes of the last AGM, held, March 24th 2015, at the Quorn Lodge Hotel, were read and approved.

Matters Arising:

There were no matters arising.

Branch Chairman's Report:

Richard Trevarthen circulated copies of his report, which were read, discussed and approved.

Finance Report:

In the absence of Treasurer David Wilks, Richard Trevarthen read the Statement of Accounts, for the period ending December 31st 2015 that David had forwarded to him.

The statement showed that the Branch had, for the first time for several years received an annual Grant, calculated as follows:

Per Capita Grant £385, plus a meeting grant of £125. Total £510.

This figure has been restricted by 50% due to the funds currently held on deposit at the secretariat and in Branch exceeded £1000. This resulted in the Grant to the Branch was £255.

Overall Branch expenditure was lower than in previous years, but this cannot be guaranteed to continue in the future.

The report was unanimously adopted.

Richard Clarke, proposed by Richard Trevarthen, Seconded by Charles Szabow was also elected to the committee.

It was agreed that the Chairman would contact David Pullin, and Phillip Wright, (who were members of the committee last year), to see if they were willing to stand again this year.

President's Address:

Following the AGM, Graham Higginson delivered the President's Address on behalf of our President, Mark Kibblewhite.

The President's Address led to a general discussion on some of the topics outlined.

Any Other Business:

- 1). Diane Yates stated that it would be nice to see more ladies attending the Annual Dinner/AGM in future. All agreed with this and it was to be made a priority for next year.
- 2). Richard Trevarthen stated that having all our meetings taking place on the second Tuesday of the month, 7.00 for 7.30pm start, had proved very popular, as it enabled members to plan well in advance. The downside was that one or two members could not attend, having previous commitments. So he said he would send out a questionnaire to all members before the next Committee Meeting, asking them to let him know which evening was best for them, and we would plan accordingly.
- 3). Richard said that a Committee Meeting will be arranged for sometime in early May 2016, to discuss and plan the 2016/17 Branch Programme. David Yates kindly said he would host the meeting at his premises again....as per last year.

There being no other business, the meeting closed at 9.45pm.
