It comprises the President, President-Elect, Immediate Past President, Past President, Honorary Treasurer, Three Vice-Presidents and Chair of Membership Committee, Chair of the Professional Development Committee, up to 20 ordinary members, Branch representatives, Douglas Bomford Trust representative and ex-officio member(s).

The purpose of the Advisory Council shall be to advise the Executive Committee on any matters that Executive Committee refers to it and any other matters that it wishes to refer to the Executive Committee.
